
ORDERED that:

1. The Motion is GRANTED.
2. The Assignee is hereby authorized to retain Jodi Daniel Dubose, Esquire, and the Law Firm of Stichter, Riedel, Blain & Postler, P.A. to represent him in this proceeding under Fla. Stat. §727.108(7), *nunc pro tunc* to the date of the assignment, or February 7, 2022. Such counsel may be compensated at the rates set forth in the Motion upon request to this Court by separate motion with notice to creditors.

¹ Capitalized terms not otherwise defined herein shall have the meaning as ascribed to such terms in the Motion.

3. The Assignee shall be paid the usual and customary rate of compensation for an Assignee in an assignment of benefit of creditors case, which is 10% of total receipts during the case, upon request to this Court by separate motion with notice to creditors.
